

Minutes from April 24, 2023 Regular Meeting of the Board of Directors at Sewerage Agency of Southern Marin 450 Sycamore Avenue, Mill Valley

New regulations from EPA are expected to be implemented to entities next year. Nute presentation included information concerning the refurbishment of the SASM outfall line from plant to Raccoon Straits. Capital Improvement Project progress- upgrades complete, retained \$100k for any possible problems. SASM rates will increase in 2025.
