- 1. <u>Call to Order:</u> Chair Kious called the meeting to order at 6:00 P.M. Present: Lew Kious, Linda Rames, Anne Lahaderne, Casey Bertenthal, Robert Cox, Dave Haflich, Shonn Dougherty (District Manager).
- 2. <u>Approval of Minutes</u> for October 23, 2023 Meeting. Motion to Approve by Linda, Seconded by Casey. Approved 5-0.
- 3. <u>Public Open Time:</u> Old Business Item 1., and New Business Item 1. Lew moved up to Public Open Time.
 - 8.1 MVRS Contract Renewal (Gene Della Zoppa- MVRS Vice President will present contract) Gene was present, Lew informed Board about meeting with MVRS officials a few weeks prior to go over the MVRS/ASD contract. The version of contract created with revisions after that meeting is version Board has in packet. County Counsel for ASD and Counsel for MVRS will review and have final draft ready at the next Board Meeting for approval.
 - 7.1 RESOLUTION 2023-03 ASD Resolution authorizing submittal of application(s) for all Regional CalRecycle and Grant Programs for which Almonte Sanitary District is eligible. Garrett Toy (General Manager) of Tamalpais Community Services District presented information about the Regional Grant available for Sanitary Districts interested in having TCSD taking the lead with compliance, reporting, and distributing Grant money. ASD is eligible for \$75k in grant money. Garrett explained that the main benefit of TCSD taking lead in Regional Grant would be to evaluate every District (with R3 Consulting services) making sure all compliances, reports and money spent for services meet all the requirements of SB1383. Almonte will be the 7th of 9 local Sanitary Districts to join Regional Grant if Board approves. Lew requested monthly updates by TCSD about how grant money is spent and what compliances are being met month by month. Motion to approve Regional Grant made by Casey, Seconded by Anne. Approved 5-0.
- 4. <u>Secretary-Treasurer's Report:</u> Casey reported as of this warrant cycle in fiscal 2023-24, we have spent \$94,271.89 which is 7.2% of the annual budget. This period equates to 42% of the 2023-24 annual budget year. We have \$878,897.36 remaining in reserves. Motion to approve made by Robert, Seconded by Linda. Approved 5-0.
